Session 2: Community Forum (7:50-8:30p)

- 1. **Topic 1:** Encourage Participation; information sharing (esp. for those without computers); Block Captains
- 2. Topic 2: Maintenance Violations (e.g., weeds and trash)
- 3. Topic 3: Communication (e.g., weekly email, calendar invite, digital & print)
- 4. Open Session:
 - a) Neighborhood Civility- appreciated ongoing training to support bias awareness. Live in a diverse community, but some don't feel comfortable at times. Want to encourage kindness and acceptance of one another. Perhaps there is a city entity that could help us with this topic and could be a guest speaker at another quarterly meeting.
 - b) Another Neighborhood Civility Issue- Shared a racial incident that occured with a neighbor.
 - c) Systemic Racism- Live on the Alameda- strongly urge adopting a racial equity lense. Want the Board to think about impacts of neighborhood policies. Believe slate roofs cause hardship for some. Want the Board to think about vestiges of legacy policies.
 - d) Home Values/ Covenant- Slate roofs cause hardship for some. Want Board to start focusing on color of roof to have a shared appearance as opposed to the product. Think the guidelines need to be brought up to date because it can be exclusionary.
 - e) HOA awareness- This is not always shared openly when you buy a house. Feels there is a lot to know and some may be unaware. Thinks it is unfair that ballots go out to only dues paying members. Richard noted: GNCA executive secretary sends out Welcome Packets to all new home buyers.
 - f) Covenant- communication is key because people need to know before buying. Are documents static or can the documents be updated. Richard: Amendments involve a neighbor petitioning and presenting a comparable material. The amendment is reviewed and voted on at a quarterly meeting to get the covenant amended.
 - g) Past Real Estate agent- had architectural guidelines at Open House. Think about reaching out to the Board of Realtors.
 - h) Bought a house because of affordability and proximity to family. Disadvantages to living on The Alameda. Can't see roofs. Don't think there is a benefit to purchasing slate in this location. Seller (flipper) denied there was a covenant. In these uncertain times, this person believes this is not a priority.
 - i) GNCA- a group of neighborhoods that ONA is part of. GNCA is sharing the Architectural Guidelines with new home buyers. Changes are possible, but not easy.
 - j) Incoming VP- look forward to serving on the Board and learning about the Covenant/ home selling process and how he can help.
 - k) 23 year resident- The Alameda- these issues are the fault of the neighborhood when the Board allows someone to make a change to their house that does not follow the

guidelines and then others follow suit and the guidelines become difficult to enforce. Why isn't there more community participation? If dues are voluntary, neighbors should be able to vote.


