1. Convene & Introductions

2. Special Guests:

- State's Attorney's Office, Andrea Curley, NE Community Liaison
- Mayor's Office, Kevin Gillogly, Neighborhood Liaison
 - Discussed the Violence Reduction Initiative and increases in the number of police cadets for the first time in years; outlined the process for getting a meeting with the Mayor; invited everyone to attend Baltimore Day in Annapolis on February 7th (bus reservations filling up fast); answered questions about water bill inquiries, street lights and trees.

3. President's Report (Jess)

- Northwood Plaza Update: Meetings with other neighborhoods are held monthly. MOU with neighborhoods needs to be updated. The statements of support and opposition regarding the BP Stations late night permit application has been submitted – without personal identifying information.
- Looking Ahead to 2018 Letter to all households with dues request will is forthcoming.
- Owner/Rental Registry investigating ways to establish a tracking database so we can get the correct information to either tenants or property owners.
- Spring Block Meetings Hoping to schedule small block gatherings again in the spring to get to know neighbors and encourage people to join/participate.

4. Vice President's Report (Scott)

Discussed things we'll be working on this year, including: Improved ONA Engagement in 2018:

- We will continue the street by street engagement started in 2017 with the CHAP discussions to create more opportunities to meet and share with neighbors in the coming months
- The goals of these sessions is to help facilitate neighbors meeting neighbors in settings which are not our typical events
- Some suggestions have been a "porch crawl" or a progressive dinner around various houses, so more information is to come

Broader Neighborhood Coordination with GNCA and surrounding areas:

- We would like to partner with some of our surrounding communities with events and other activities GNCA communities, Greater Waverly and others

5. Covenant Matters Committee Report (Mary) Applications and Violations

Since the September 2017 Meeting the Covenant Committee and Board have processed thirteen (13) applications for exterior alterations and six (6) violation letters. Some of the current properties we are dealing with regarding Violations include:

- 4212 Kelway Successfully worked with the flipper who installed non-compliant new windows and non-compliant a new front door without ONA approval to bring the property into compliance. The property is now compliant and was recently sold.
- 4051 The Alameda Working with the flipper who installed a non-compliant asphalt shingle roof and who needs to restore the front porch that was removed by the City after condemnation. This flipper has submitted an application for new windows, but resolution of the roof and the porch is outstanding.
- 1310 Southview The flipper installed non-compliant windows.
- **1012 Argonne** Working with the flipper who is painting the brick, siding and shutters and installing new doors and windows. They started work without applying, but are now in full compliance with our process and guidelines.
- 4023 The Alameda Flipper has installed non-compliant windows.

6. Maintenance and Housing Committee Report (Stephen) *Upcoming Events:*

- Dumpster Days TBD- Hope to have the dates confirmed by the end of the month.
- Mayor's Community Cleanup Days in Spring and Fall of 2018 keep an eye
 out for dates. Suggestion was made to have block captains lead the effort on
 their blocks, solicit students who need community service hours, and the
 need to develop proposals to submit for GNCA maintenance funds.
- Roundtop resident requested help maintaining Roundtop circle (common areas).
- Steve L. offered to go door to door with volunteers to engage neighbors before a violation notice is sent and/or to get proposals for maintenance of the common areas.
