VP motioned to give \$25 to host of popsicle night for each week it occurs. Motion was seconded by Diahn. Vote: 5 in favor and 1 opposed.

## Treasurer

2016 dues dollars are down compared to 2015. 38% of households have paid vs 42%. ONA usually has a balance of approximately \$18,000 and it's currently \$16,000. Idea was raised to possibly increase membership dues. Previous president, Richard Skolasky, did pay incorporation fee. It should be due again 4/15/2016. LLC cost is \$300 annually. P.O box will be added next week (week of January 18,2017) for check payments. GNCA will have little hold on money. ONA fiscal year is the calendar year. Will check into LLC payments. Budgetary issues will be addressed in February meeting. ONA does have revenue making activities. Raffle of some type is suggested at wine and cheese social.
